

**MINUTES OF**  
**BOARD OF HARVEY COUNTY COMMISSIONERS**  
**CANVASS OF AUGUST 2 PRIMARY ELECTION**

**August 8, 2016**

The Board of Harvey County Commissioners met in special session to canvass the August 2 Primary Election on August 8, 2016. All three commissioners were present. Chairman Westfall called the meeting to order at 8:00 a.m.

Rick Piepho, Election Officer, reviewed the primary election. Harvey County has 21,070 registered voters and 6,561 cast ballots in the Primary Election, representing a 31.14% turnout. There were 1,398 total advance voters (453 by mail and 945 early voters). There were 737 advance by mail ballots sent including 27 UOCAVA ballots sent, of which 12 were returned. Rick reported that the turnout was higher than other past primary elections and higher than expected with turnout probably driven by the contested race for Sheriff. He also reported that the election went smoothly. He displayed the new election results website and showed the levels of detail that are available to visitors.

The Election Office received 117 provisional ballots which are included in this canvass.

Sixty provisional ballots were presented for voters who moved within the county but did not change their voter registration. Commissioner Hague made a motion to approve the 60 ballots for counting. Commissioner Krehbiel seconded the motion and it was passed unanimously.

Fourteen provisional ballots were presented for voters who changed their name by marriage but did not change their voter registration. Commissioner Krehbiel made a motion to approve the 14 ballots for counting. Commissioner Hague seconded the motion and it was passed unanimously.

Five provisional ballots were presented for voters who changed their name and moved within the county but did not change their voter registration. Commissioner Krehbiel made a motion to approve the 5 ballots for counting. Commissioner Hague seconded the motion and it was passed unanimously.

Ten provisional ballots were presented for voters who were sent an advanced ballot by mail and did not return the ballots to the election office. They went to the poll on Election Day and were required to vote a provisional ballot. The election office verified that the mailed ballots were not returned. Commissioner Hague made a motion to approve the 10 ballots for counting. Commissioner Krehbiel seconded the motion and it was passed unanimously.

One provisional ballot was presented for a voter who voted provisional because of a clerical office error. The registrant was incorrectly marked as deceased in the Election Voter Information System. Commissioner Hague made a motion to approve the 1 ballot for counting. Commissioner Krehbiel seconded the motion and it was passed unanimously.

One provisional ballot was presented for a voter who was not listed in the pollbooks due to lack of citizenship documentation. The voter provided citizenship documentation after the pollbooks were prepared but prior to the deadline. Commissioner Krehbiel made a motion to approve the 1 ballot for counting. Commissioner Hague seconded the motion and it was passed unanimously.

One provisional ballot was presented for a voter whose voter registration was incomplete because they did not provide proof of citizenship, but the voter registered at the DMV. A recent court ruling exempts DMV registrants from the Kansas law requiring proof of citizenship documentation and a separate court ruling requires that their complete ballot be counted. Commissioner Krehbiel made a motion to approve the 1 ballot for counting. Commissioner Hague seconded the motion and it was passed unanimously.

One provisional ballot was presented for a voter who moved within the county but did not change their voter registration. The ballot voted was incorrect because the voter was at the incorrect poll site. Therefore the ballot should be only partially counted with just the identical races on both ballot styles counted. Commissioner Hague made a motion to partially count the 1 ballot. Commissioner Krehbiel seconded the motion and it was passed unanimously.

Three provisional ballots were presented for voters whose voter registration was incomplete because they did not provide proof of citizenship prior to the midnight on August 1 deadline. Commissioner Hague made a motion to not count the 3 ballots. Commissioner Krehbiel seconded the motion and it was passed unanimously.

One provisional ballot was presented for a voter who went to their poll site on Election Day but was listed in the pollbook as having voted early during the in-person advance voting period. The election office confirmed that the voter did vote during the in-person advance voting period. Commissioner Krehbiel made a motion to not count the 1 ballot. Commissioner Hague seconded the motion and it was passed unanimously.

Two provisional ballots were presented for voters who received a ballot for the wrong political party because of poll worker error or voter insistence. Commissioner Hague made a motion to not count the 2 ballots. Commissioner Krehbiel seconded the motion and it was passed unanimously.

Eighteen provisional ballots were presented for voters not registered in Harvey County. Commissioner Hague made a motion to not count the 18 ballots. Commissioner Krehbiel seconded the motion and it was passed unanimously.

Ninety-three approved ballots were counted and added to the Election Day results, 24 ballots were not counted.

Rick reported that the final turnout percentage for the county increased to 31.58% with 6,654 total ballots cast (5,512 Republican & 1,143 Democratic).




The election canvass was adjourned at 9:00 a.m.
